Application for Credit Terms & Conditions

Declaration and Signature

- 1 I/We acknowledge that the completion of this credit application does not constitute an offer of credit by Burwood Resource Recovery Park Limited ("BRRP") and that BRRP may reject my/our application for any reason.
- 2 I/We confirm that all of the information in this credit application is true and correct. I/We will notify BRRP immediately if there is any change in any information set out in my/our application.
- 3 I/We agree to the BRRP terms and conditions detailed below.

Privacy

- 4 I/We acknowledge that BRRP will collect, use and securely hold information set out in an application for credit for the purpose of providing products or services to me/us, and/or in providing me/us with information on products and services that BRRP thinks might be of interest to me/us. If I/we ask BRRP not to provide me/us with this information, BRRP will comply with my/our request. I/We may ask BRRP to show me/us the information it holds about me/us and to make corrections to it.
- 5 I/We agree that BRRP or any authorised agent of BRRP may collect information about me/us from any person who can provide BRRP with information that is of relevance to it. I/We consent to BRRP giving my/our information to any person who can assist it with providing products or services to me/us and/or in developing or running its business.
- 6 I/We understand that BRRP will conduct a credit check on me/us and I/we authorise those credit agencies to disclose information that they hold about me/us to BRRP. As part of that credit check, BRRP will give my/our information to credit reporting agencies. Credit reporting agencies will use the information provided by BRRP to update their credit reporting databases. When other parties use the credit reporting agencies' services, they will be provided my/our updated information. BRRP might use credit reporting agencies' services in the future for purposes related to the provision of credit to me/us. For example, BRRP may use credit reporting agencies' monitoring services to receive updated (if any) of the information held about me/us. If I/we default in my/our payment obligations to BRRP, the default information will be listed on the credit reporting agencies' databases and will therefore be disclosed to other parties when they use the credit reporting agencies' services.

Personal guarantee

- 7 I/we agreed that I or the majority shareholder, sole trader or owner will provide a Personal Guarantee to BRRP if requested as part of this Application for Credit.

Payment

- 8 I/We will pay the full amount of my/our account no later than the 20th of the month following the date of invoice or such other payment terms advised by BRRP.. Due to the large volume of demolition material and the credit exposure to BRRP these terms will be strictly adhered to. Failure to make any payment by the due date may result in immediate refusal of entry at the Facility gate or the withholding of services "on account".
- 9 I/We agree that we are wholly liable for all amounts owing to BRRP under this contract or any other terms and conditions even if I/we am/are acting as an agent for other parties.
- 10 BRRP has the right to charge interest on all outstanding balances. If BRRP is required to undertake action for recovery of outstanding debts from me/us than I/we will pay BRRP the reasonable costs and disbursements incurred by BRRP (including on a solicitor client basis) for any such action. BRRP may pass accounts outside the terms of payment onto a solicitor or debt collection agency for collection.
- 11 Payment by cheque, other bills of exchange or promissory notes shall not be deemed to have been received by BRRP (or its employees, contractors or agents) until cleared.
- 12 If I/we default in payment, breach these terms and conditions, or are adjudged bankrupt, liquidated or dissolved, or a receiver or administrator is appointed, BRRP may, notwithstanding any waiver by BRRP of such default in payment or breach and without prejudice to its other rights, suspend delivery of products or services, cancel any order or require payment in cash on delivery of products or services, notwithstanding the terms of payment specified in this contract.
- 13 Any payment received from me/us may be supplied by BRRP to all or part of the amount owing for any products or services provided to me/us as BRRP sees fit, irrespective of whether that payment is intended by me/us to be for a particular product or service or in respect of a particular invoice.
- 14 Payment shall be made in full with no right of set-off or deduction.
